For the additional facilities that must be provided by the corporation as aforesaid, Fashnear Technologies Private Limited will initiate the License after completion of NOC from government authorities for smooth operation, so that company can start the further process like- Site Agreement, Advertisement, Interior or exterior work at finalized site.

Upon entering into a license Agreement with Meesho Group, Franchisee shall be permitted to sell all domestic, international and cargo products hereunder, under the trade name Meesho and its trademarks. Franchisee shall not be entitled to, and shall not, use or register on its own Meesho trade names, brand names or any other similar name or simulation or contraction thereof. The Franchisee shall also not be entitled to use, nor register on its own behalf the trade names, brand names or any other similar name or simulation of Meesho.

The Franchisee shall be entitled to append its Brand name "Meesho" or "Authorized Valmo Outlet Franchise" at the preferred location" in that order. In case of failure on the part of any payment compliances on the part of FRANCHISEE due to which, Fashnear Technologies Private Limited is called upon to pay such amount, the same shall be recovered from the franchisee. Fashnear Technologies Private Limited may terminate this Agreement by written notice if there is a direct or indirect change in the- ownership, shareholding, re-constitution or change in control of the FRANCHISEE. In such an event parties may execute a fresh "LETTER OF INTENT" to continue the business relationship in which case the FRANCHISEE shall provide all the required supporting documents in this regard.

Once approved a "Franchise" letter of intent will be provided or sent. Please sign and return within 24hrs from the time of letter issued. Payments made to Fashnear Technologies Private Limited to be refundable based upon your acknowledgement.

The company will not be held liable for any loss or damage on account of delay that may be caused in providing you the facilities mentioned above, whatever may be the cause of the failure of delay.

You shall not induct any partner in case of individual (s) or making changes in the constitution of the partners as existing at the time of application, except your spouse as per terms and conditions of the OMC (Name), and shall give an undertaking to this effect.

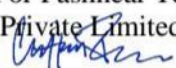
